No textbook is required. Readings and references will be made available as needed.

#### Course Description

Introduction to relief printmaking techniques with concentrated work in the processes of wood cut and linoleum cut.

The course also introduces collagraph, monotype, intaglio, stencil, and lithographic processes. Given that this is a required course for the Art Education degree, particular attention will be given to how printmaking may be integrated into an educational setting.

#### Course Objectives/Student Learning Outcomes

- To demonstrate knowledge of printmaking terminology, methodology, and materials
- Demonstrate responsible handling of materials for safety and efficiency
- Participate in traditional critiques and informal discussion
- Develop research and initiative in studio work to further individual creative direction
- Study historical and contemporary printmakers and approaches to printmaking
- Show experimentation and risk taking in both conception and execution
- Demonstrate the use of printmaking media and processes as tools for ideation
- Demonstrate an understanding of multiple originals through the creation of varied prints using shared elements
- Develop problem solving skills in the image and object making process

#### Major Teaching Methods

This is an in-person studio course. Students will be instructed through demonstration, lecture, and regular critiques.

#### Course Schedule

There will be two major projects in the course, with many demonstrations and exercises in between.

The first major project is in support of Hispanic Heritage Month. We will make an edition of large prints, culminating an event on September 16<sup>th</sup> at the Craft Center. Weekly demonstrations and exercises will prepare you for the final project, a print exchange.

#### Grading and Evaluation Procedures

Grades are an indication of how well you are doing in the course.

Grades will be given with regard to the following:

- Quality and improvement in your work.
- Consistent work both in class and in the studio beyond class meetings
- Consideration and development of possible solutions to a problem
- Care and maintenance of the studio and personal equipment
- · Craftsmanship, competence with materials, and presentation
- Participation in discussions and critiques
- · Individual research and initiative

The Hispanic Heritage Month project will be worth 25% of your grade. The final 2-part print exchange book will be worth 25% for each part. Exercises and quizzes will be worth the remaining 25%.

No incompletes will be given except in the case of an EXTREME circumstance. Incompletes are never a good idea, and do not assume that you will be granted an incomplete simply because you stop attending class or do not turn in your assignments.

KEEP ALL WORK UNTIL THE END OF THE SEMESTER. Art students should remain aware that they will need work for scholarship applications and progress reviews.

# **Attendance Policy**

Attendance is mandatory, and you will be expected to be in class and on time for each scheduled meeting. Extracurricular activities are not a license for absence. Consideration will be given for a death in the family and serious illness (which may be confirmed by a doctor.) Any work missed as the result of an absence MUST BE completed or a substitute completed. If you miss class you are still responsible for the same quality and quantity of work as if you had been present. It is your responsibility to be prepared for the next studio after your absence. Beyond two absences, there will be a grade deduction of five points per absence. Two late arrivals (15 minutes after start of class) or two early departures (15 minutes before end of class) are counted as one absence. **Students missing seven or more classes will fail the course.** 

Students who are unable to attend class for an extended period of time due to an emergency/extenuating circumstance (i.e., medical illness, hospitalization, death in the family/bereavement, military or legal obligation), may contact the Office of the Vice President for Student Affairs at <a href="mailto:studentaffairs@tntech.edu">studentaffairs@tntech.edu</a> to request an absence notification.

#### Class Decorum

Be respectful in speech and action. Anything that disrupts the class or hinders the learning process is unacceptable. This includes but is not limited to cell phones, texting, social media, meals, and inebriation. Such disruptions will count as half an absence each offense. Students are responsible for regular studio cleanup.

# Class Participation

Critiques are mandatory! Critiques offer immediate feedback from peers and from the professor. Failure to attend and participate in a scheduled critique will result in a lowered grade. Progress in coursework requires outside-of-class steps. Failure to complete those steps as assigned may result in your inability to proceed with in-class studio work. Such cases will result in an absence marked. An example of this is the preparation of a surface requiring overnight drying time.
